ECOREX ACTION PLUS is an insecticide product for professional use against flying and crawling insects including flies, mosquitoes, moths, wasps, ants, cockroaches, earwigs, silverfish and other bristletails, fleas, bedbugs, beetles, spiders, mites, ticks and lice for use indoors and outdoors in domestic situations, commercial and industrial premises (including kitchens), amenity areas, hospitals (excluding occupied wards), military establishments, food storage and preparation areas, in and around farm buildings plus refuse disposal and waste storage areas.

Because of its special characteristics, ECOREX ACTION PLUS could be used indoors and outdoors.

ECOREX ACTION PLUS has an immediate and prolonged protective action lasting at least 3 weeks after application. Its special water-based formulation ensures an odourless product.

MODE OF USE:
