## Directions for use:

Add a small quantity of water to a suitable compression sprayer and then add product according to the table below. Add the remainder of the water, close the sprayer securely, shake to mix contents. Pressurise according to the sprayer manufacturer's instructions. One litre of ready-foruse spray treats 20 square metres of surface. Make up spray as required. Do not store spray overnight.
