First aid measures in the event of accidental exposure?

General:

Call a poison centre or a doctor if you feel unwell.

In case of skin contact:

Immediately wash with water and soap and rinse thoroughly. Take off contaminated clothing. If skin irritation or rash occurs: Get medical advice/attention.

In case of eyes contact:

In case of contact with eyes, rinse opened eye immediately with plenty of water and seek medical advice. Remove contact lenses, if present and easy to do. Continue rinsing..

In case of Ingestion:

Rinse mouth out with water. Call A Doctor immediately. Do not induce vomiting. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. If unconscious, place in the recovery position and seek medical advice. Obtain emergency medical attention..

In case of Inhalation:

In case of unconsciousness place patient in recovery position and get emergency medical advice. Remove person to fresh air and keep comfortable for breathing. Loosen tight clothing such as a collar, tie, belt or waistband. Exposure can cause numbness, tingling and weakness in extremities.
