APPLICATION RATE

Surface spray.

For heavy infestations:

Dilute 250ml of product with 9.75 litres of water then apply 1 litre of diluted product per 25 square metres of surface or spray short bursts directly at insects.

For routine treatment:

Dilute 50ml of product with 7.95 litres of water then apply 1 litre of diluted product per 25 square metres of surface.

APPLICATION RATE

For heavy infestations:

Dilute 250ml of product with 9.75 litres of water then apply 1 litre of diluted product per 25 square metres of surface or spray short bursts directly at insects.

For routine treatment:

Dilute 50ml of product with 7.95 litres of water then apply 1 litre of diluted product per 25 square metres of surface.

The (COSHH) Control of Substances Hazardous to Health Regulations 2002 may apply to the use of this product at work.

Engineering control of operator exposure must be used where reasonably practicable in addition to the following items of personal protective equipment.

Wear suitable protective clothing and suitable gloves.
